### CAREER OPPORTUNITY

The National Maritime Safety Authority (NMSA) is responsible for promoting, complying with and maintaining world class maritime safety standards in Papua New Guinea consistent with legislation and commitments under National Legislation and International Conventions in order to facilitate a safe, efficient and environmentally responsible shipping sector for stakeholders in government, industry and the community. Under the mandate, NMSA ensures a fully functioning and effective network of aids to navigation; availability of high quality and up to date navigational charts; that vessels meet the safety standards required by law and international commitments; ensuring seafarers' competency through vigilant examination and certification, and coordinating maritime responses to distress calls and monitoring and controlling ship-sourced pollution. The NMSA now wishes to fill the following positions:

#### Ship Inspection Officer (Deck/Nautical Officers)

##### **Job Objective**

To ensure that all vessels operating in PNG waters fully comply to national and international maritime safety standards. Ensure all overseas and domestic ships are inspected in accordance with the standards set in the PNG Merchant Shipping Act, Radio Regulations and the International Maritime Organization (IMO) Conventions.

##### **Principal Accountabilities and Services Standards**

Among the core accountabilities, the successful incumbent will:

*Carry out Flag State Inspection (FSI) to comply with national legislation; carry out Port State Inspection (PSI) on all eligible foreign flag vessels to ensure they comply with relevant international standards; conduct periodic inspections on all PNG vessels to ensure compliance to the Merchant Shipping Act; conduct inspections on fishing vessels to comply on safety standards as required; and compile inspection reports and submitted in a timely manner; and ensure NMSA values and code of conduct, OHSE and related policies and procedures are adhered to at all times.*

##### **Person Specification and Experiences**

The successful person for this position must meet the following requirements:

##### Skills

High level interpersonal skills; effective communication skills; good level of analytical and assessment skills; strong management, organizational skills and advance computer skills with good report writing skills and the ability to innovate and recommend better ways of doing things.

##### Knowledge

Demonstrated knowledge and understanding of FSI and PSI; PNG Merchant Shipping Act; shipyards and or shipping administration and safety standards.

##### Qualifications

Minimum qualification is Master class 2.

##### Experience

Minimum of 3 years of relevant work experience as a ship surveyor/inspector or experience in ship yard or equivalent.
